REGISTRATION CONDITIONS

Cancellation Statement: Cancellations received in writing (events@ahuri.edu.au) to AHURI by Sunday 29 July 2024 will be accepted and all fees refunded less an administrative fee of AUD \$100. Cancellations received after this date cannot be accepted and will not be refunded. A replacement delegate may attend the conference instead of the original delegate – must advise in writing of change sent to events@ahuri.edu.au.

Transfer of registration: Your registration can be transferred to another person at no charge on the first occasion; subsequent changes will incur a cost of an administrative fee of \$100 GST inclusive (this includes transferring an already transferred registration to another person). The full name and details of the person that will replace you must be advised in writing (events@ahuri.edu.au) to AHURI prior to the conference.

Non-attendance: No refunds will be made for non-attendance at the conference.

EARLY BIRD DISCOUNT CONDITIONS
